INTRODUCTION AND ORGANIZATION

The Department of Education of Bamanpukur Humayun Kabir Mahavidyalaya organised online extension programme on Environment Day dated 5.6.20. The requisite permission was sought from the principal of the college for the same online, and the allotment of time and date was confirmed Notice were circulated to the students and the teachers accordingly online.

BACKGROUND OF ONLINE EXTENSION

In India, around 250 million students were affected due to school closures at the onset of lockdown induced by COVID-19. The pandemic posed several challenges in schools and colleges which included an expected rise in dropouts, learning losses, and increase in digital divide. Covid-19 pandemic is the first and the foremost a health crisis. The World-Wide lockdowns because of the global pandemic have affected many important sectors adversely, one of them being the Education sector. The pandemic forced many schools, colleges and universities to keep it closed abruptly. In a short span of time, the students were exposed to online learning. The sudden change of classroom learning to digital learning impacted the learning of the children belonging to low-income families. As they were not able to afford smart phones, computers or laptops, wi-fi etc. came to become their immediate disadvantage. All the schools and universities have created online curriculum structure for day-to-day teaching and learning and also shifted, postponed or cancelled many regular and competitive examination. It has also increased the students need to adapt at using gadgets and online platforms overnight. Online schooling has created a digital spilt among the rich and the poor students. Majority of the students from the rural areas were unable to explore the online learning as they were having limited or no internet access. The educated parents were able to support their children throughout the pandemic in their learning but they were parents who are illiterate and also their helplessness to help their children in learning. Bamanpukur Humayun Kabir Mahavidyalaya although located in the rural area, the students prepared for the on-line extension on observation of world Environment day.



OBSERVATION OF ENVIRONMENT DAY

Environment day is celebrated worldwide on 5th June to create awareness among people about protecting the environment. The first-ever Environment Day was held in 1973. Environment Day acts as a platform that helps create awareness about various issues that have adverse effects on the environment, like global warming, overpopulation, pollution, and crime against wildlife.

The environment plays an integral role in maintaining the balance of the ecosystem we live in. Most people don't understand the importance of the environment and end up damaging it with their various activities. If we continue to degrade the environment, in the long run, the adverse effects will affect human beings too. So, to protect the environment, one should focus on sustainable development. 
