PURPOSE OF THE MOU

In particular, this MOU is intended to

- 1. Exchange of faculty for organizing seminars/symposia/conferences/academic activities in collaboration as and when required
- 2. Exchange of students of both institutes for add-on/certificate courses/special classes

NOW, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREED AS FOLLOWS:

Clause 1

- 1. A. Both parties are united by common interests and objectives, and they shall establish channels dommunication and co-operation that will promote and advance their respective operations. The parties shall keep each other informed of potential opportunities and shareallinformationthatmayberelevanttosecureadditionalopportunities for one another.
 - B. The co-operation between the First Party and the Second Party will facilitates of effective utilization of the intellectual capabilities of both the parties by providing significant inputs to them in developing suitable teaching/learning/training systems, keeping in mind the needs of both the parties.

Clause 2

SCOPE OF THE MOU

- 2. A. Both parties believe that the close co-operation between the two would be a major benefit to the students and or teachers of both institutes to enhance their skills and knowledge.
- B. The Both Parties will give valuable inputs to each other in teaching/learning/training methodology so that the students are ready for the job market.
- C. Both the Parties would organize seminars for the advancement of knowledge in selected fields of education. In such cases the expenditure would be borne by the host Party.
- D. Selected students of the First Party may avail themselves of any Career Training programme/short-term courses to be offered by the second Party. In that case, participating students of the first Party would be provided accommodations free of cost in the hostels of the second Party. As for food and other logistical expenditure, the first Party will bear the costs.





Clause 3

VALIDITY

3. A. The validity of the MOU is 5 (five) years from the date of agreement. 3. B. Both Parties may terminate this MOU upon 30days' notice in writing. In the event of Termination, both parties have to discharge their obligations.
